#### Introductions

#### **Operating Procedures**

A copy of the draft Memorandum of Agreement (MOA) was distributed to everyone for review. Several edits were recommended and incorporated into the draft MOA. Dick Price had questions on why some of his comments had not been incorporated into the MOA. Each of Dick's comments were reviewed and more of Dick's comments were incorporated into the MOA. The MOA will be updated and emailed out as soon as possible to the Initiating Agencies and Implementing Governments for initial review by department heads, legal, councils and boards. Changes will be collected by the next meeting and hopefully agreed to for final review and approval.

## Potential WRIA 54 Planning Unit Membership/Representation

A potential WRIA 54 Planning Unit membership list was distributed to everyone for review. A few edits were made plus the addition of Robyn Meenach from the Washington State Farm Bureau. It was agreed that the addition of new members could happen as long as the new potential member had attended three regular monthly meetings and the Planning Unit voted to approve them as a new member. It was also agreed that the removal of an existing member could occur if the member had not attended the past three regular monthly meetings and the Planning Unit voted to remove the member. Similar language will be incorporated into the MOA.

The Initiating Agencies and Implementing Governments agreed to invite the potential list of Planning Unit Members to the next meeting to begin organizing the Planning Unit.
